






Countries of region show large shares of domestic population out of country




Remittances/GDP (%), 2013



Central Asia export: resource- and capital-intensive in labour-rich region




Remittances to Exports, FDI and ODA





Labour market driver: Jobless workers








Income differential as a driver




De facto labour market integration





Remittances from Russia as share of total remittances





Moldova: Currency structure of personal transfers





Transfers to and from Russia and Central Asia





Cost of remittances







What will the future bring? Will remittances continue to fall?



- Forecasts to 2030, based on:
 - UNDESA projections for labour force growth
 - IMF projections for GDP growth
- Maximum, minimum migration (remittances) scenarios developed
- Results:
 - For Central Asia downturn of 2014-2016 is a "blip"
 - Even minimum scenario shows large migration (remittance) flows resuming in 2017


Demographics continue to increase "jobless" workers in poorer Central Asian countries, reduce them in Russia


Some convergence in income levels but not much

GNI per-capita relative to the Russian Federation





Old-age dependency ratio








Main migrant route to Germany




Share of remittances from Russia, sent by non-residents



Intended directions of migration






Type of inflow	Concentration	Targeting
Export receipts	Concentrated or highly concentrated	Profit, reinvestments, expansion of production
Foreign direct investments	Highly concentrated	Profitable investments
Foreign aid	Concentrated	Development oriented, targeted
Remittances	Widespread	Consumption general and special (80-90%)

Kyrgyzstan: Poverty reduction effect of remittances





Kyrgyzstan: regional differences in remittances and poverty reduction





Perception of Recent migration's impact in Kosovo society




Moldova: impact of migration on children


Percentage of Children Saying Family Roles Not Filled






